#### Nearly Half a Million Dollars for Innovative Programs

Supported by donations from local businesses, the PWCS Education Foundation has been able to provide nearly 100 grants to Prince William County teachers and schools, as well as to School Division departments, staff, and offices, through our "Innovative Grants" program. Thanks to the generosity of our community, the Foundation has provided more than \$444,000 in grant funding for this program since 1999, which allows schools and departments to implement programs that would not be possible otherwise. In FY 2009, the Education Foundation generated over \$750,000 in funds, goods, and services for the students of Prince William County Public Schools.

# 2008-09 Highlights

#### **Innovative Grants**

- Provided funding for "Space Week," a program to teach students about the vision of our space pioneers and scientific processes as they relate to real-world situations. The event included hands-on exhibits, classroom workshops, a portable planetarium, and visits to the Udvar-Hazy Space Museum.
- Funded "The Green Artist: Promoting Conservation Rather than Consumerism," a program that sent
  - students to the Hirshorn Museum and Sculpture Garden where they met with an educational team that explained the mechanics of "found object" and "recycled object" art. Students then created pieces from recycled objects to display in a school-based art exhibition that promoted environmental conservation.
- Provided an opportunity for lowachieving ninth-grade students to experience live Shakespearean theater performed by a professional acting troupe at their school. The program provided an economical and practical way to introduce high school students who rarely have the opportunity to experience live theater to this artistic medium.
- Funded "Prince William Head Start Earth Day," an
  event that provided hands-on activities and education stations for children and their families to learn
  about environmental topics, outdoor safety, and
  youth organizations that support social conscience,
  leadership, and citizenship skills.
- Provided funds to purchase a "Talk and Listen Kit" that allows one interpreter to provide information quietly and simultaneously to multiple individuals as part of the Parent Resource Center's efforts to assist families that speak other languages.
- Funded the purchase of Flip Video Camcorders and other audio recording devices so students in foreign language classes can further explore the culture they are studying by creating multimedia presentations that provide "virtual tours" of Latin American countries.
- Provided funding for "See It! Read It! Hear It!,"
   a program that uses a digital visual presenter to
   magnify literature so that all children, including
   those with special needs, can see the books or other
   materials that a teacher is reading aloud to them.
   Research shows that interactive read-alouds are
   beneficial for children who are learning to read.
- Funded the building of "Flailing Seamus Studios," an in-school recording studio that allows teachers to

- assist special education students to reach the same educational goals as regular education students. This educational project uses the music studio, constructed by the school's shop students, to produce music as a motivational tool that helps special needs students retain information and improve social skills.
- Provided funds to establish an after-school Robotics Club for the Western-end elementary schools. These
  - clubs partner with Battlefield High School student mentors to give elementary school students exposure to activities that spur their interest in pursuing careers in science, technology, engineering, and math.
  - Funded "Get in Touch," a program
    to improve vocabulary development
    and increase language acquisition
    among students who are deaf and
    hard-of-hearing through the use

of interactive and multimedia lessons. Through the use of touch-screen laptops, students are able to access visual learning materials to help them acquire the necessary skills to become fluent readers and fluent communicators.

#### **Activity Highlights**

- Hosted the "Honoring Our Heroes in Education" gala to recognize individuals and businesses that made a significant impact on education and learning in Prince William County.
- Funded the School Division's "Saluting Our Student Stars" event (formerly the Classy Awards) to honor students who have been recognized for significant scholastic, artistic, and athletic achievements.
- Awarded four high school seniors \$1,000 each to pursue a career in teaching as part of the Dr. Edward L. Kelly Memorial Scholarship program.
- Sponsored the 16th Annual "Tee Off for Education" golf classic fundraising event.
- Collaborated with Lockheed Martin to host the 9th Annual Superintendent's Business Breakfast to provide a "State of the Schools" update and spotlight the School Division's commitment to providing a World-Class Education.
- Established a "Holiday Helpers" giving program to provide food, gifts, and warm clothing to familiesin-need identified by the School Division.
- Partnered with the VA STAR program to provide refurbished computers to students who would typically be unable to have access to a computer at home.
