I am grateful for the opportunity to serve as president of the SPARK Board of Directors for the 2018-19 school year. I have been directly involved with Prince William County Public Schools (PWCS) for many years serving as chair of the SPARK Scholarship Committee and member of the Board of Directors. Having also served as co-chair of the Smart Beginnings of Greater Prince William Sustainability Committee and volunteering at the annual Prince William County SeaPerch Underwater Robotics Competition, I believe my experience will allow me to leverage support for students, teachers, and staff to strengthen the foundation of education in this *World-Class* School Division.

Supported by donations from local businesses, SPARK raises funds for Prince William County teachers and schools, as well as School Division departments, staff, and offices, through our "Innovative Grants" program. In 2017, over \$80,000 was awarded to schools and departments to implement programs that would not be possible otherwise. The Foundation continues to support the use of our enhanced web presence in all Division schools, and continues to support students pursuing careers in teaching, Science, Technology, Engineering, and Math (STEM), nursing, and many other private programs through our scholarship program– awarding over \$82,000 to 57 graduating seniors this past school year.

Each year we embark upon initiatives to help make education brighter for our students. We now support more than seven scholarship funds; play a vital role in the Virginia Student Training and Refurbishment (VA STAR) Program; provide clothes and gifts to families in need via our Holiday Helpers initiative; provide support for Robotics teams in all of our schools, and continue to bring awareness to the importance of early childhood education through support of Smart Beginnings Greater Prince William. This year, SPARK incorporated the CTE Advisory Committee to support high school programs for cyber security, welding, automotive, culinary, cabinetry, engineering, HVAC, and other classroom instruction.

The support that SPARK is able to leverage enriches students' lives every day. These children are the basis for our community's future growth and prosperity, and it is only possible to build on that strong foundation with the continued support of our corporate and community partnerships. The quality of our schools is more than simply a desirable community feature. A strong PWCS is vital for the future success of our county, state, and nation. Activities and Events

Sponsored the 25th Annual "Tee Off for Education" golf classic fundraising event to **support innovative grant distribution** to our departments and schools.

Hosted the 18th Annual Superintendent's Business Breakfast to provide a "State of the Schools" update, spotlight the School Division's commitment **to excellence**, school to business/ community partnerships, and innovative grant successes.

Program Support

Continued fundraising for the "Holiday Helpers" giving program to include Volunteer Prince William's Un-Trim-a-Tree program and the Fraternal Order of Police Battlefield Lodge #43 Santa Cop program to **provide food, gifts, and** warm clothing to families-in-need.

Provided continued extensive **support and financial assistance to the VA STAR** (Virginia Student Training and Refurbishment) program to include the expansion of the program to other School Divisions in the Commonwealth of Virginia.

Continued support by providing more than \$75,000 in funding for the Divisionwide enhanced web presence, raised by leasing and managing commercial advertising space on PWCS school websites. PWCS **provides an online communication platform for teachers, students, and parents so they can share information**.

Continued support for the Science, Technology, Engineering, Arts, and Mathematics (STEAM) initiatives. This includes **providing a robust selection of robotics programs** and career and technical education opportunities to schools.

Support for the Smart Beginnings Coordinator position, working to **improve the quality of care and education** for children from birth until kindergarten and to ensure that children are ready to succeed in school and in life.

Scholarships

In 2018-19 SPARK distributed \$73,000 to graduating high school seniors, totaling 45 awarded scholarships to 23 different colleges and universities.

- Awarded three high school seniors \$1,500 each to pursue a career in teaching as part of the Dr. Edward L. Kelly Memorial Scholarship program.
- Awarded five \$1,500 scholarships to students pursuing a career in the Science, Technology, Engineering, and Mathematics (STEM) field through the Micron Foundation and Lockheed Martin.
- Collected funds and managed activity for the Kevin Simpson Memorial Scholarship fund.
- Distributed two \$1,500 scholarships to CTE students to pursue their education at a post-secondary school, two scholarships, one for \$1,500 and one for \$2,000 for CTE students to further their education at a trade school or an associate's degree, and one \$1,500 for the CTE Red Lawson scholarship. These are all on behalf of the CTE (Career & Technical Education) Advisory Council Fund.
- Distributed a \$4,000 scholarship to one PWCS high school senior on behalf of Chick-fil-A restaurants in Prince William County.
- Distributed \$1,000 on behalf of the David J. Cobb Memorial Scholarship.
- Distributed \$1,000 to a student to continue education on behalf of the Dr. Renee Lacey Memorial Scholarship Fund.
- Distributed \$1,000 on behalf of the David J. Cobb Memorial Scholarship.


